Duval, Nassau, Columbia, Suwannee, Alachua, Clay
Baker, Union, Bradford, St. Johns, Putnam, Flagler,
Volusia, Marion, Hamilton for six months prior to
January 23, 2010.

Facts:

- ★ Talent required being no longer than 90 seconds, props restricted, no accompanist – only soundtracks.
- ★ All meetings and interview are mandatory unless otherwise authorized by a pageant official.
- ★ TWO 5x7 headshot photos required with no crown. Must be professional quality photos.
- ★ Production, Introduction, Talent, Evening Wear and Swimsuit cards and copy of birth certificate due ASAP!
- ★ Competition wardrobe must be approved by a pageant official for local and state.
- ★ **NO PARENTS OR FAMILY ALLOWED BACKSTAGE.**
- ★ **NO CAMERAS OR VIDEOS** are allowed during competition.
- ★ All tickets and monies must be turned in by January 17, 2010.
- ★ The Jacksonville Scholarship Foundation, Inc. will offer special assistance, training, and wardrobe tips to those contestants who obtain their own sponsors. The Pageant will try to assist contestants who may have difficulty in finding a sponsor. ***SPECIAL NOTE:** Once you have made a commitment with a sponsor and signed a contract, you will then be offered assistance and training in interview, wardrobe, etc. Upon obtaining your own sponsor you can then make your talent selection and request a tentative contestant line-up number. (**Not required.*)
- ★ Once you have obtained a sponsor and sell \$195.00 of advertising, you will receive 20% of all ads and patrons money that you raise in the form of a special scholarship. You must present receipts of tuition or diploma if you have already graduated from college in order to receive this scholarship money.
- ★ **PROOF OF RESIDENCE** must be provided in the form of copies of two of the following: Current FL Driver's License or FL Auto Registration issued for at least 6 months, current voter's registration card or written statement from the voting registrar of valid current registration in Jacksonville area, or current lease in the contestant's name for housing in the Jacksonville area. The above should indicate your residence in the pageant area for at least 6 months prior to pageant date.

** A contestant must be at least 17 years of age by January 23, 2010, or when contract is signed. A contestant must not be older than 24 years of age by December 31, 2010.
